Message From The President

It's been a busy year up and down the Overmountain Victory National Historic Trail. It's also been very busy for the OVTA. The 2015 year has rolled by so fast and yet, we've noticed a lot of good things happening on the trail. The OVTA has stepped up to take a more active role in it's mission to protect the trail and to tell the story.

As we've been celebrating our 40th Anniversary, it's apparent that we are entering a new era of participation, outreach, and growth. During our 2015 Annual March, despite the rainy weather, we reached approximately 10,700 people with "The Story" most of whom were fourth graders. Estimates of contacts through media coverage from newspapers and TV stations, are near 500,000. Even after the Annual March the OVTA reached an additional 2,000 people with programs. We were able to carry out this huge task with support from the Ticket To Ride Grant and the Cooperative Agreement with the National Park Service. Through the work of our Director of Interpretation plus an expanded Cooperative Agreement with the National Park Service we are now positioned to tell the story year around.

This year's Annual March saw some amazing highlights: Participation of the Tennessee State Guard at the crossing of Sycamore Shoals, river crossings over the Holston and Catawba Rivers, Revolutionary War Weekend events in Morganton, NC and in Gaffney, SC, and NPS booths and Ranger programming all along the trail.

Our Fall Meeting and workshop was held on November 20, 21 in Elkin, NC. We were thrilled and inspired by the moving presentation of **Robert Rambo** as he did a first person presentation as Cherokee Chief **Attakullakulla**, "Little Carpenter."

NPS Ranger **Margo Blewett** conducted a black powder safety class. Other hands-on activities included tomahawk throwing, fire starting with flint and steel, period clothing, colonial dance and period cooking.

The Wilkes-Surry Chapter hosted the event and offered sessions on some of the least known personalities on the Eastern Wing of OVT including Ben Cleveland, Joseph Winston, Martin Gambill, and William Lenoir.

Truly the fall workshop was a great way to wrap up 2015! Our successful year was due largely to the excellent working relationship with the National Park Service, the planning and programming of our Director of Interpretation, **Steve Ricker**, our volunteer Annual Marchers, and the OVTA Board of Directors. I really appreciate this team and think we have one of the most talented and dedicated groups that I've every witnessed in a non-profit organization. A huge thanks for all you do! **Huzzah!**

I would like to wish you and your family happy holidays, and hope to see you at our Annual Meeting in January.

SUMMARY OF THE MARCH

Much to the likings of 1780, this year's marchers traveled the trail in very wet conditions. Weather in no way prevented many successes and firsts along the trail on way to the 235th Anniversary of the Battle of Kings Mountain...

Fortunately, the rains let up so the waters could rescind for river crossings. OVTA reenactors were joined for the first time ever by the Tennessee State Guard in crossing the Watauga River at Sycamore Shoals. Two additional crossing firsts were the crossing of the Holston River at Choates Ford in Bluff City, TN and the crossing of the Catawba River in Morganton, NC.

As is done every year, reenactors shared the story with many students along the trail; however, this year's March on Main in Gaffney, SC made a first when reenactors were joined by more than 100 students of the Gaffney High School Jr. ROTC and Drum Corp.

The inclement weather actually enabled OVTA travelers of the trail a small amount of down time so many were able to make their first visit to Fort Thicketty—a newly acquired property set for preservation that you will be hearing more about in the upcoming months.

Firsts for the 2015 would not end when we reached the top of Kings Mountain the morning of October 7th. For the first time in history, reenactors were permitted to fire muskets during the morning ceremony and for the afternoon program, OVTA members were able to tell the stories of the men at the Battle of Kings Mountain on Kings Mountain.

There were so many wonderful 2015 stories to share from each community along the trail that we have begun compiling those stories, articles and photos to present a Report from the March at the April meeting.
